Dear Sir/Madam,

This is with reference to our earlier communication dated 11th September, 2018 requesting you to update your PAN and Bank account details with our Registrar and Transfer Agent as required in terms of circular dated 20th April, 2018 issued by the Securities and Exchange Board of India.

For your reference, the comments of our earlier letter are reproduced below:

The Securities and Exchange Board of India has by its circular SEBI/HP/MIRSD/DOP1/CIR/P/2018/73 dated 20th April, 2018 mandated that companies through their Registrar and Transfer Agents ("RTA") take special efforts for collecting copies of PAN and bank account details of their security holders holding securities in physical form.

Those security holders whose folio(s) do not have complete details relating to their PAN and Bank Account, or where there is any change in the bank account details provided earlier, have to compulsorily furnish the details to the RTA / Company for registration / updation.

Since we have not received any response from you for updating the information, we once again request you to send us the following documents in order to update your PAN and Bank account details in the Company's records.

- Enclosed format duly filled in and signed by the shareholders
- Self-attested copy of Pan Card of all the security holders
- Cancelled Cheque leaf with name (if name is not printed, bank attested copy of the pass book first page showing name of account holder) of the First holder
- Address proof: Aadhar / Passport / Utility Bill (Not older than 3 months) of the First holder
- Any change in the name of holders
