We have reviewed the unaudited financial results of National Peroxide Limited (the "Company") for the quarter ended June 30, 2018 which are included in the accompanying Statement of Standalone Unaudited financial results for the quarter ended June 30, 2018 (the "Statement"). The Statement has been prepared by the Company pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "Listing Regulations, 2015"), which has been initialled by us for identification purposes. The Statement is the responsibility of the Company's management and has been approved by the Board of Directors. Our responsibility is to issue a report on the Statement based on our review.
- 2. We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement.
- 3. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and, accordingly, we do not express an audit opinion.
- 4. Based on our review conducted as above, nothing has come to our attention that causes us to believe that the Statement has not been prepared in all material respects in accordance with the applicable Accounting Standards prescribed under Section 133 of the Companies Act, 2013 and other recognised accounting practices and policies, and has not disclosed the information required to be disclosed in terms of Regulation 33 of the Listing Regulations, 2015 including the manner in which it is to be disclosed, or that it contains any material misstatement.
- 5. The financial results of the Company for the quarter ended June 30, 2017 were reviewed by another firm of chartered accountants who issued an unmodified conclusion, vide their report dated August 9, 2017.

 This statement has been prepared in accordance with the Companies (Indian Accounting Standards) Rules 2015 (Ind AS) prescribed under Section 133 of the Companies Act, 2013 and other recognised accounting practices and policies to the extent applicable.

 The Company's business segment consists of a single segment of "Manufacturing of Hydrogen Peroxide" as per India Accounting Standard (Ind AS-108) Operating Segment requirement.

 In accordance with Indian Accounting Standards, sales for the quarter ended June 30, 2018 and March 31, 2018 is net of Goods and Service Tax (GST), however sales till period ended June 30, 2017 is inclusive of Excise Duty.

 Exceptional items for the year ended March 31, 2018 includes refund of Rs. 105.92 lakhs received from Maharashtra State Electricity Distribution Co. Ltd. towards tariff difference between continuous supply and non continuous supply of power, recovery of additional fuel adjustment charges and load factor incentives for earlier years.

6. The figures for the quarter ended March 31, 2018 are the balancing figures between the audited financial results for the year ended March 31, 2018 and the published unaudited financial results for the nine months ended December 31, 2017.

7. The statutory auditors have carried out a limited review of the standalone results for the quarter ended June 30, 2018.

8. Previous year / periods figures have been re-grouped / re-classified wherever necessary.
